We reserve the right, at our sole discretion, to change or modify portions of these Terms of Service at any time. If we do this, we will post the changes on this page and will indicate at the top of this page the date these terms were last revised. We will also notify you, either through the Service user interface, in an email notification or through other reasonable means. Any such changes will become effective no earlier than fourteen (14) days after they are posted, except that changes addressing new functions of the Service or changes made for legal reasons will be effective immediately. Your continued use of the Service after the date any such changes become effective constitutes your acceptance of the new Terms of Service.

#### Access and Use of the Service

Services Description: The Service is designed to provide an audio <u>-based</u> and/or video-based live streaming and social networking platform. The Service allows users to create and monetize live audio and/er video broadcasts and digital art represented on non-fungible Ethereum-based tokens-("\_"NFTs"\_") that are generally available to all other users. Users who join an audio and/or video broadcast may be permitted by the host to participate in and contribute to the audio and/or video broadcast.

Recording by Fireside: Fireside records and saves all audio and for video streams broadcasted through the Service. Fireside does this in order to improve its products and services, provide you with recommendations, and to ensure the security and integrity of its platform. If you are not comfortable with Fireside recording your broadcast or any contributions you may make to a broadcast, please do not contribute to the broadcast and/or disable your audio and/or video functionality.

Media Export Requirements: Fireside may make certain audio and/or video streams available for export to

broadcasters and other authorized third parties. With respect to any audio and/or video <u>streams</u> exported from the Service, you agree to: (1) provide public attribution to Fireside when you share any content first created within the Service; (2) use and not modify the Fireside audio mark when <u>distributing distribution</u> any such content to other platforms; and (3) allow Fireside to publish your content, unless you are bound by any exclusivity or other restrictions.

We aim to admit and correct any errors in our content and hold ourselves accountable. We are subject matter experts in our areas of focus and refrain from making statements of fact on issues we are not qualified to speak on (e.g., giving medical advice/opinions without holding proper qualifications and/or education).

**Understanding & Empathy**: We build meaningful relationships with the internal and external Fireside community and engage in active listening throughout all of our interactions. We seek to increase understanding through approaching all conversations, shows and interactions from a place of empathy towards all points of view.

**Humanity**: We have the ability to respectfully disagree and engage in civil discourse with grace. We are mindful of the impact our words have on others.

**Inclusivity:** We believe in building a community that respects everyone's diversity - not only in terms of race, ethnicity, religion or socioeconomic status but also in terms of diversity of thought, opinions and ideas. We do not tolerate content which is divisive and aims to exclude certain groups or ideas. Content which breeds social detachment runs counter to our mission to create a positive and more inclusive world.

#### **Prohibited Activity**

**Misrepresentation / Fraud:** Intentionally spreading false information is not allowed. You may not make, or use any content made available through the Service to make any misleading or deceptive statements, including by omitting other pertinent facts or context, misattributing or misquoting statements made by any other user, or combining content to produce misleading or deceptive statements.
